OUR VISION

Minnesota Elder Justice Center is a trusted resource that improves lives, communities and systems with, and on behalf of, elders and vulnerable adults.

OUR MISSION

To mobilize communities to prevent and alleviate abuse, neglect and financial exploitation of elders and vulnerable adults.

OUR WORK

The Minnesota Elder Justice Center is a statewide nonprofit organization working to prevent and alleviate abuse, neglect, and financial exploitation of older and vulnerable adults. All of our services are free of charge.

AREAS OF FOCUS:

Direct Victim Services

Support, advocacy and legal representation services to older and vulnerable victims of abuse, and their families, are at the heart of our work. We also provide technical assistance to professionals who work with older adults. **Our staff supported over 625 victims and families in 2020.**

Training & Education

Our staff provide statewide education opportunities to the public and professionals so they can be informed, help those around them, and build communities that do not tolerate abuse against older and vulnerable adults. We provide entry-level and advanced training to individuals and institutions who work with older and vulnerable adults. Our audiences include professionals representing social services, the legal community, health care, financial institutions, and others. A specialized 8-hour training is available for law enforcement and criminal justice professionals. In 2020, this work was primarily done virtually.

We provided trainings and presentations reaching over 6,000 individuals in 2020. Minnesota's 2020 World Elder Abuse Awareness Day Conference had over 450 attendees participate in a virtual three day conference.

Public Policy & Systems Change

We advocate for policy initiatives that benefit older and vulnerable victims of abuse, prevent abuse, and hold perpetrators accountable. Staff work with county and community teams to support a coordinated response to elder abuse.



In 2020, our staff worked collaboratively to further develop and determine the Rules associated with new Assisted Living Licensure regulations. In addition, Minnesota Elder Justice Center helped advance legislative changes to modernize Minnesota's guardianship laws. Finally, Minnesota Elder Justice Center staff continued work with others to move towards updating Minnesota's Vulnerable Adult Act.

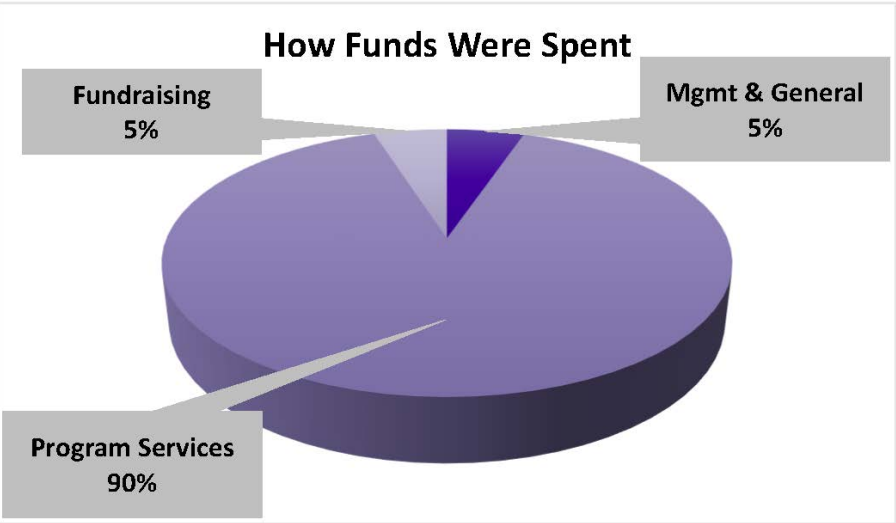
